At the outset the Chairman, SUGC, welcomed all the members present, and subsequently, the agenda was taken up for discussion.

#### Item No. 2: Announcement, if any

The house was informed that the APEC Report of 2018-19-II semester will be presented by the Acting Chairperson of APEC Dr. Alakesh C. Mandal and a request was made to the members of the SUGC to go through the data of the students of their respective department and if any correction is required in the said data then the same may be informed to the UG Office.

# Item No. 2: Consideration of the report of the Academic Performance Evaluation Committee (APEC) based on the academic performance of students at the end of 2018-19-II Semester.

The committee was apprised that members of the Academic Performance Evaluation Committee (APEC) met on 17<sup>th</sup> to 21<sup>st</sup> May, 2019 for evaluation of the Academic Performance of the undergraduate students at the end of 2018-19-II semester. Based on the guidelines of the UG Manual APEC Report was prepared by the APEC. The said report was presented by before the SUGC by Dr. Alakesh C. Mandal, Acting Chairman, APEC, for consideration and further recommendation to the Senate for its approval. After going through the APEC Report, it was decided that the report will be sent to the Senate for further consideration subject to some minor corrections in the report.

# Item No. 3: Consideration of the request of Mr. Suraj Kumar Barnwal (150742) a BT student of ME Department to allow him to take 4 courses in Summer-2019 and to give waiver 2 OE credits for completion of his academic program at the end of Summer-19.

The committee was apprised that in its last meeting (2018-19/5<sup>th</sup>), it was decided that students of 2015 and earlier batches will be allowed to take three courses in Summer-2019 irrespective of credit limit, provisionally subject to obtaining approval of the Senate, for completion of their academic program at the end of Summer-19.

But another request has been received from of Mr. Suraj Kumar Barnwal (150742) a BT student of ME Department to allow him to take 4 courses in Summer-2019 and to give waiver 2 OE credits for completion of his academic program at the end of Summer-19. However, the total registered credits of the student will be 27. Since the student had requested for allowing him to register four courses instead of three, as earlier recommended by the SUGC to the Senate for its consideration, the request of the student was considered by the SUGC. Keeping in view on the completion of the academic program at the end of Summer-19, it was decided that the previous recommendations of the SUGC on the credit limit of the summer registration needs to be modified and it may be instead of three courses. it may be 32 credits (half of the maximum credit limit of a regular semester) irrespective of the number of courses. Accordingly, student will be allowed to register 4 courses in summer provisionally and recommendation will be sent to the Senate to consider the request of the student.

# Item No. 4: Consideration of the requests of the students to give waiver against the courses they had cleared in other University/Institute as a non-degree student under Exchange Program
