## Minutes of the 2022-23/3rd meeting of the SUGC held on Tuesday, November 29, 2022, at 3:30 PM in Room No. 208, Academic Affairs Building, IIT Kanpur

At the outset, the Chairperson, SUGC, welcomed the members present and subsequently after announcement and Action Taken Report (ATR), the agenda items were taken up for discussion.

Item No. 1	Consideration of proposal for change of credits for students with academic deficiency	1
	(amendment in clause 6.1.6 of the new UG manual).	

The committee members discussed the proposal to change credit limits for students with academic deficiency [Academic Probation (AP/AP\*) and Warning (WR)] and after due deliberations, the committee members recommended the following proposal to be sent to the Senate for final approval:

- (1) The upper limit of credits for students on Academic Probation (AP/AP\*), which is currently 35 credits, be increased to 38 credits. This amounts to three 9 credits and one 11 credits course.
- (2) The upper limit of credits for students on Warning (AR), which is currently 45 credits, be increased to 49 credits. This amounts to three 9 credits and two 11 credits courses.

After approval from the Senate, the above proposed changes will be updated under clause 6.1.6 of the UG manual.

Item No. 4 Consideration of new course proposal from the Department of	of Economic Sciences

The proposal of a new course from Economics Sciences department with title 'Carbon Markets, Trade and Energy' was discussed and proposal of a new course has been approved by the committee.

The UG office will create a course code for this course and will inform the ECO department.

Item No. 5	Consideration of proposal of ME department that student may opt any Elective to
	fulfill UGP-2 and UGP-3 course requirement

The revised proposal of Mechanical Engineering department for change in template (BT/DD/DM) related to mandatory UGP-2 (ME451A) and UGP-3 (ME452A) courses which can be replaced by the OE or DE courses with equivalent credits was discussed and after due deliberations, committee members recommended proposed flexibility provided by the ME department to students to the Senate for final consideration.

As per proposal of ME department, following proposal has been recommended and forwarded to the Senate:

- 1) 9 credits corresponding to UGP2 (ME451) can be replaced by OE or DE.
- 2) 6 credits corresponding to UGP3 (ME452) can be replaced by OE or DE.
- 3) In addition, UGP option will be open only to interested individual students based on a CPI based selection criteria
- 4) Partial credit of a course could not be counted towards fulfilment of UGPs requirements. Students should have cleared/registered for two individual courses.

Item No. 6	Consideration of course waiver request of Ms. Shubhi Kesarwani (190837/BT/ME) to	
	complete graduation requirement	

The request of Ms. Shubhi Kesarwani (190837/BT/ME) to replace theory part of ME231A with ESO204A course was discussed in the meeting and after due deliberation, the committee decided to recommend her course waiver request to the Senate for final approval.
