The applicants would be interviewed by the Committee.

**GUIDELINES, TERMS & CONDITIONS AND SUBMISSION OF EOI**

**Eligibility and Qualification:**

- (a) **Yoga Instructor** - Graduate in any subject or equivalent from a recognized University and should have one year training or Certificate or Diploma or Bachelor Degree or equivalent in Yoga from a recognized Institution.
- (b) **Dance Instructor** - Senior Secondary School Certificate with 50% marks or Intermediate with 50% marks or its equivalent and Bachelor Degree or Diploma or Certificate in Dance or equivalent from a recognized University
- (c) **Music Instructor** - Senior Secondary School Certificate with 50% marks or Intermediate with 50% marks or its equivalent and Bachelor Degree or Diploma or Certificate in Instrumental Music or equivalent from a recognized University

The Qualifications are relaxable at the discretion of the Selection Committee, for reasons to be recorded in writing, in the case of candidates otherwise well qualified.

**Scope of empanelling of instructors:**

- (i) Faculty/ Staff/ Students and families from campus community will register for the above-mentioned classes.
- (ii) Classes are to be conducted in the designated rooms/ halls as per slots provided by the institute clubs.

**Submission of Applications:** Applicants will submit their applications with all relevant enclosures in the prescribed format as per Annexure II in sealed envelope clearly marked "Expression of Interest (EOI) for Empanelment of Instructor" so as to reach on the abovementioned address on or before Jun 30, 2022 up to 17:00 hrs.

Incorrect, incomplete, inadequate information may lead to rejection of the application. Canvassing in any form may also lead to summary rejection of application.

**Selection procedure:** The instructors would be empaneled on the basis of assessment made by selection committee after taking into consideration qualification, experience and interview of the applicants.

**Payment:** Payment will be made to instructors on cost sharing basis from the revenue generated from the registration fees of participants.

**Tenure of the Empanelment:** The empanelment shall be initially for a period of one year extendable up to five years on year-to-year basis as per requirement of the Institute subject to consent of both parties.

**Termination:** The Agreement may be terminated by giving three months' notice by the Institute.
