The following issues were discussed in MSWC meeting held on 25th September 2022, 19:00hrs

- · AA/Z block lift problem during collection of garbage and in monsoon:
- Water logging in the electric meter room in New SBRA: There is water collection in the meter room during monsoon and off-times, it is a potential threat to the property and serious damage of lives can cause due to short circuit.
- CUGL: Billing related, No Dues related, New guidelines a detailed change in billing process, connection and reconnection charges and importantly role of sbra to be involved in NO dues, All residents can pay connection and work related amount to mswc only, to avoid inconsistency. Action against irregular bills and discrepancies in bills and unjust amount taken from students
- Dustbins, Garbage collection and sanitation related issues in all SBRA: No regular cleaning is done in spite of asking them, as per institute guidelines it must be done on alternate days and Sundays off(cleaning only).
- Welcome kit for the new students giving them detailed instructions and important contacts and inventory related description in printed format, So that they are aware of rules and also known to CUGL related, IWD related,

and Electrical related work done processes and also are aware of taking meter reading(cugl) before accepting the house.

· House maids in SBRA rate to be revised and an appeal to the residents to refer to it when employing the house maids: a very high inflated price is being asked by maids mentioning everyone is paying.

Accounts has been updated since 2019 December within 7 days of accepting the office charge (30/09/2022):

Common area lighting requirements related: in old sbra and in new sbra

- Dogs issue in the new sbra solution as to use steel gates similar as used at other areas inside the campus
- DCF (40000): NO parking (new sbra); SBRA office and guest room; Notice board
- The removal of old abandoned cycles and vehicles parked in SBRA parking, these unwanted abandoned cycles takes up a lot of space in parking area and creates ruckus in the area also attracts reptiles.
- The meeting with all the staff working in SBRA was done to understand working norms and rules
- Meeting with chief Sanitation officer was done: Manish ji and MSWC
- Meeting with Superintendent IWD was done to clear all backlogs and shorten the time taken by IWD
- Meeting with JE Electrical was done regarding recurrent failures on timely services and asking justification some denials in the service.
