MSWC Minutes held on 9h July 2018

The following issues were discussed in MSWC meeting that was held on 9th July 2018:

- 1. Budget allocation for the purchase of RO: MSWC has decided to purchase two RO, one for Old and other for New SBRA. MSWC has felt the necessity because the current capacity of the RO's are not sufficient to meet water demand of the residents. A budget of 85000 /- has been allocated for the same.
- 2. Budget allocation for the purchase of AC: MSWC has decided to purchase an AC for the second guest room also. A budget of 28000 /- has been allocated for the same. For the second guest room the residents have always a choice of booking it as an AC or Non-AC. The charge of AC and Non -AC guest rooms are Rs.350 Rs.200 respectively.
- 3. Budget allocation for the purchase of Access Points for Old SBRA: MSWC has decided to purchase Access Points for Old SBRA also. A budget of Rs. 80000 /- has been allocated for the same. (Anubhou, VIKASM)
- 4. The issue of one of the aspirants of SBRA quarter related to the application: One of the Ph.D. students, M. Rashid Zafar of Mechanical Engineering department has approached the SBRA office requesting the consideration of his application for upgrading his waiting list in SBRA (on priority). Previously, he was the resident of SBRA, which he vacated as he converted his Ph.D. from regular to part time program for working at the capacity of assistant professor in AMU. Now, he has come again to complete his degree. He has applied for SBRA but he wants to upgrade his waiting list on priority basis. The case was extensively discussed in the meeting, and the committee unanimously decided to go as per the SBRA constitutional norms. Thus, the committee has felt not to entertain the request by the aspirant.
