The following issues were discussed in MSWC meeting that was held on 8th September, 2015:

### 1. Ratification of minutes of MSWC meeting held on 9th August 2015

There were no corrections in the draft minutes. Minutes were finalized and will be uploaded on website.

# 2. Finalizing the quotations of RO purifiers

Out of all the quotations given by various companies for RO purifiers, SAINI World, Kanpur had given the quotation of 30,000 Rs per RO (50 LPH). It was decided that 2 RO purifiers will be purchased from this company (Total 60,000 Rs) and will be installed at water cooler, old SBRA and Y block, new SBRA respectively.

#### 3. Discussing "Deshvandana" Feed-backs and discussing future budget allocations for events

A feedback survey was conducted and from the responses we got 75% of residents feel that the amount spent on food (12000) was justified. Also 50% of the residents feel that before conducting an event with such high amount, MSWC should conduct a survey. It was decided that for any event if the amount of money to be spent is more than 10,000 Rs, than MSWC will have to conduct a survey amongst residents for the approval of budget.

#### 4. Status of implementation of decisions taken by MSWC

• "Decision raised on eligibility of Mr. Burra Gunashekhara as SBRA resident": In the previous meeting it was decided that Mr. Burra Gunashekhara will have to vacate SBRA by 20<sup>th</sup> August. As he could not do so, he will be fined with guest room charges of Rs 200 per day from 21<sup>st</sup> August onward, till 20<sup>th</sup> October.
