### 3. Discussion on new rule of house shifting


There were few changes made in the existing rule.

- a) The earlier condition of at least one year stay in SBRA has been removed. According to new rule all residents are eligible for resident waiting list for shifting house (except those who have shifted once under this rule).
- b) Earlier condition of shifting within 4 days has been changed to 5 working days. Now a person after being allotted the new house has to shift within 5 working days irrespective of issues like white-washing and CUGL disconnection. After 5 working days, a fine of Rs 500/- per day will be imposed.
- c) Resident has to shift within maximum 15 days of acceptance, if not shifted, his/her name will be removed from resident waiting list forever. Also a fine for 10 days will be imposed as per above rule.
- d) Information regarding vacated house will also be placed on notice board of SBRA along with sending mail.


### 4. Charge handover to new MSWC committee
