5. Fixing of Maid Charges

In order to ensure the uniformity in terms of payment made for domestic help and for nannies at SBRA, MSWC along with some female residents of SBRA have set the following payment guidelines:

However, residents are free to pay more than the aforementioned rates depending on the amount of workload in their respective house. Please note that these are just guidelines and MSWC is not enforcing them as rules. MSWC is only intended to maintain some uniformity in payments and to keep the ever increasing ceiling limits in check. Note that these rates will be applicable from July'16. Residents can deduct

proportional amount on per day basis from payment if maids/nannies are taking more than two leaves in a month.

6. Food Stall in SBRA (Further Discussion)

A south Indian food stall was allowed in SBRA premises on temporary basis by MSWC. Based on the feedback from the SBRA residents, MSWC decided to let this stall continue in SBRA premises. In feedback many residents felt that the food items are overpriced, MSWC has revised the rates as follows:

MSWC has asked the stall owner to continue her stall from July'16 first week. Moreover, to maintain the quality of served food and other standers, MSWC will take the feedback of the stall from residents quarterly, so the next feedback of stall is due in Sept'16. Based on the feedback, MSWC will decide whether to let this stall further continue or not. However, MSWC reserves all the writes to get this stall closed any time.

7. Lighting of badminton court at NSBRA

MSWC wrote an application to the concern authority for installing lights on the badminton court at NSBRA. In same reference, MSWC received an answer that institute is willing to put lights provided SBRA takes care of the electricity bill. The issue has been discussed and MSWC decided to first talk to concern person to get the rough estimate of the bill amount and then a survey will be floated to ask the residents for the possibilities of bearing the electricity bill by SBRA.

8. Issue of utilizing activity center effectively

In order to utilize the activity room regularly at least for some time, some residents of SBRA came forward with a proposal to open activity center for kid's activities along with some childhood education for the children of SBRA under the supervision of a trained teacher and a maid. MSWC has taken the matter in to consideration and asked the residents along with convener SBRA to come up with final footprint of the proposal.

9. Status of implementation of decisions taken by MSWC in previous meeting

- a) Application for taking M-2 house under SBRA has been processed and house M-2 is now under SBRA. Application for static security guard in old SBRA along with the signatures of old SBRA residents has also been processed.
- b) Application for the installation of dustbins in old and New SBRA, application for the cleaning of shades, meter rooms etc. and application for the installation of mosquito mesh in old SBRA are under process. These applications will be processed soon.
