The following issues were discussed in MSWC meeting that was held on 16 Sept'16:

1. Ratification of minutes of MSWC meeting held on August 26th, 2016

There was no correction in the draft minutes and minutes have been uploaded to the website.

2. Inclusion of SBRA under Dean's capital fund (DCF) scheme

The salary of Mahendra is on hold since July'16.To draw the salary of Mahendra form institute, it is compulsory for SBRA to join DCF like other hostels. With the current income and maintenance charges, it is not possible for MSWC is to afford Mahendra's salary. After discussing the matter with previous conveners (who are still SBRA residents), MSWC members and some senior SBRA residents informally, the issue of SBRA's inclusion under DCF was discussed formally in the meeting. The conclusion of formal meeting and informal meeting (with previous conveners, MSWC members and senior residents) was in favor of inclusion of SBRA under DCF. Now, MSWC will write to DOSA to process the matter formally. To join DCF, MSWC has to share 50% of the guest room income with the institute same as other hostels. In return, institute gives office staff salary (some other benefits like other hostels).

3. Discussion over some cases regarding residents staying without wife

In particular, Mr. Chetan Patel's (Residents of F-2) case was discussed. According to claim by him and some residents via mail, Mr. Chetan has been staying without his wife since first week of June'16. Further, Mr. Chetan asked to stay alone till October'16 on medical ground. However, based on the documents given by resident and subsequent discussion over the case in MSWC meeting, Mr. Chetan Patel has been given

extension to stay without wife till 7th October'16. Hence, he has to bring his wife by 7th October'16. He is also required to meet to the convener once his wife is here. Further, since, he has been staying alone since June'16 (almost four month), he is liable to stay with his wife till the end of this session. Else, he has to vacate the house. Here, MSWC would like to mention that Mr Chetan and the residents (who have supported Chetan) are liable for action if the claim (Mr Chetan has been residing without wife since first week of June'16) by them is found wrong.

4. Possibilities of renting out sound system for SBRA residents

MSWC has decided to rent out the sound system for SBRA residents on trail basis for three months with the following terms and conditions:

- 1. The sound system will be rented out strictly for the SBRA residents only within institute premises on first come first serve basis.
- 2. There will be following three slots (three hours each) for taking the system on rent.
 - > 11:30 AM to 2:30 PM
 - > 3 PM to 6 PM
 - > 6:30 PM to 9:30 PM
- 3. The charge per slot is Rs. 500 (400 + 100 convenience charge). The payment will be in advance through cheque only.
- 4. There will be no security deposit for taking the sound system on rent.
- 5. To ensure the proper working of the sound system at the time of issuing the system and at the time of returning the system, Mr. Mahendra is supposed to connect and disconnect the system at the venue. For this help, aforementioned convenience charges of Rs. 100 will be given to him through office. It is compulsory for resident to ask Mahendra for connecting and disconnecting the system to ensure proper functioning of the system.
- 6. The resident himself will be responsible to pick and drop the sound system at the SBRA office on time.
- 7. If faulty system is returned by a resident then the residents has to pay the repairing cost of the system. If system is not possible to repair then resident has to pay the full cost of the faulty item.
- 8. MSWC reserves all the rights to cancel the booking of any resident at any time without any explanation.

9. Status of implementation of decisions taken by MSWC in previous meeting

- a) The Application for constructing stage at new SBRA (Near Y-block) has been processed.
- b) The application for street lights for M-block has also been processed.
- c) Tin shades have been cleaned by IWD on 14 October'16.
- d) The application for the installing notice boards at new SBRA and the application for the installation of mosquito mesh in old SBRA will be processed soon.
