The following issues were discussed in MSWC meeting held on 9th Jan'17:

### 1. Ratification of minutes of MSWC meeting held on 28 Nov'16

There was no correction in the draft minutes, and minutes have been uploaded on the website.

#### 2. Problem of dogs in old SBRA

The issue of stray and pet dogs was discussed in the meeting. Coming to the pet dog's issue, Mr. Dipro Sarkar, resident I-1 is having a pet dog. According to the Dosa related security guidelines (http://iitk.ac.in/new/iit-kanpur-security), any student cannot bring and/or keep any pet such as fish, cats, dogs, rabbits etc., further; students should desist from feeding stray dogs and petting them. The MSWC has decided that Mr. Dipro Sarkar has to take written permission from DOSA, DD and Director to keep his pet in SBRA premises. As far as the problem of stray dogs is concerned, MSWC feels that 24\*7 security guard is required to solve this issue. However, to reduce this problem, we request all the residents not to feed any stray dog. The MSWC is trying hard to get 24\*7 securities.

### 3. Discussion over the case of a residents staying without spouse

In particular, Mrs. Ranupal's (residents F-6) case was discussed. The resident herself agreed that 75% occupancy is not possible by her husband. According to the SBRA constitution, Mrs. Ranupal is not liable to hold SBRA accommodation without showing 75% occupancy of her husband. Therefore, the MSWC has asked the resident to vacate the house latest by the end of Jan'17.

- b) Estimate for lighting facility at new SBRA's badminton court and for constructing stage at new SBRA is under the process of approval.

- d) The application for the street lights for M block has been reprocessed with the required changes (asked by IWD).
- e) The application for the maintenance of the main road of old SBRA has also been processed.
- f) The application for the installation of mosquito mesh in old SBRA will be processed soon.
