## MSWC Minutes held on 25<sup>th</sup> August and 9<sup>th</sup> Sept, 2013

MSWC discussed the following issues in the meeting and recommended the following actions:

#### 1 Dead & Dry Tree cutting inside SBRA

Cutting off trees in Jhula Park and inside SBRA that has withered and completely dried up was proposed. MSWC discussed in the meeting the risks involved if the tree is left to fester and decay.

#### 2 Vacate area to be used as Fruit Orchard

MSWC took a decision to use the vacant area within SBRA premises as Fruit Orchard. For this purpose, some of the fruit bearing tree saplings will be planted for SBRA community.

#### 3 Document for SBRA allotment

Marriage certificate is made mandatory for new SBRA applicants. The marriage certificate from civil court (only) should be produced to the SBRA office within three months from the date of application to the SBRA office for SBRA quarter. The applicant will be maintained in the waiting list, but if fails to submit the same within the prescribed period, his/her name from the SBRA waiting list will be deleted.

#### 4 Change in programme candidates need to apply afresh for SBRA quarter

Those SBRA Waiting - list students who have enrolled into Ph.D Programme after completion of their M.Tech Programme, need to apply afresh for SBRA accommodation. Their candidature will be on par with the fresh SBRA waiting list candidates. This decision was taken on the basis of the fact that a student ceases to be an IIT student on completion of one programme, and before enrolment into another, irrespective of the intervening period. Since this norm is prevalent in allotment of accommodation to student in IIT, it was decided that the same logic would apply in SBRA waiting list norms as well.

## **5 Car parking at new SBRA**

New SBRA residents are required to park their four wheeler at the designated car parking area only (opposite to the entrance gate). If any resident is found parking their four wheeler at any other place than the aforesaid area, then it will be treated as violation of MSWC rule.

## **6 Salary Increment of Sweeper**

Increment in the salary of SBRA hired sweeper by Rs 250/-. SBRA Guest room & washroom would be cleaned by the sweeper on every alternate day so as to provide Guests with a clean Guest room upon their arrival.

## **7 Students not married but having Dependant parents.**

In order to discourage the practice of students applying for SBRA quarter even though they are not married and on the other hand facilitating the students who has dependent parents shall have to pay the quarter charges as decide by the estate office/DoSA.

## **8 SBRA day celebration**

It was deliberated that the SBRA Day would most likely be celebrated in the last week of January, 2014
